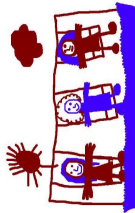

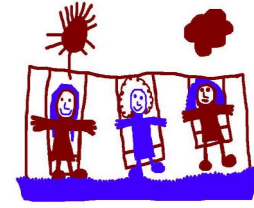

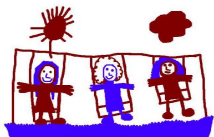

New requirements to receive In-service credit for training

To receive credit for training you must be:

- *Registered with the Ohio Professional Development Network Registry (OPDN Registry)
- *Have an Ohio Professional Identification Number (OPIN)

What to do next if...

I am not registered with OPDN – Registry and do not have an OPIN.

- Go to www.OPDN.org to register and create your OPDN profile.
- Click “Sign up for OPDN” and follow the directions..

I am registered with the OPDN-Registry, but do not know my OPIN.

- Go to www.opdn.org and log in.
- OPIN is located in the upper left corner of the page.
- Write down your **8 digit OPIN number**: (example: 1234-5678) on the registration form.

*****Failure to provide the OPIN number on the registration form will result in not being registered for a session*****
